UPDATED INFORMATION

For our clients and customers: BEL AIR AUTO AUCTION and BSC America Associates
EFFECTIVE THIS THURSDAY, June 11, 2020-
CONSIGNERS' REPRESENTATIVES are welcomed back "ON THE BLOCK"-with some restrictions!

Our sales will continue to be *Simulcast* only, however, starting this Thursday, June 11th, the Bel Air Auto Auction is pleased to be able to extend the invitation to have our consignors to represent their vehicles on "the block."

While BAAA is working toward a return to "in-lane bidding," we are not there yet. Our primary focus remains the health and safety of our clients, customers, our BSC associates and suppliers. We are working within both the guidelines of our public health agencies, including the CDC and Governor Hogan's Re-Opening Maryland plans, BAAA will continue in simulcast mode for now. As a courtesy to each of our customers, *Simulcast* fees will continue to be waived.

As you know, as an "essential business" our offices have remained open although our food services and cafeteria closed in accordance with the Governor's directives. If you have been in our offices during this crisis period, you have seen some of the changes in the form of signage, safe distancing reminders, and "Covid-screens," or plexiglass dividers, at some locations. We will continue to operate with these restrictions as well as with the enhanced cleaning and maintenance that helps all of us to continue to "be safe." But we also need, and will require, your cooperation with our safety procedures, in order to do so.

Masks will continue to be required in the interior offices, in the auction lanes, and on our lots. In addition, in accordance with CDC recommendations, each time that you enter the BAAA facility, for example, to pre-view a vehicle on our lots, or, for our consignor representatives, during the time that you are in the offices, on the lots, or on the block, repping your vehicles, we will first ask you to complete a short questionnaire. You may also be subject to a temperature screening. These steps are part of our ongoing safety procedures. For the protection of each of you, our staff and all individuals at BAAA, we reserve the ability to limit access based on those screening results.

Again, at this time, the auction lanes are not yet open for live-auction sales. While we encourage you to permit BAAA to assist you in representing the vehicles that you consign to us during our auctions, and we remain ready to assist, it is wonderful to be able to offer our clients and customers the opportunity to step back up on the block. When you register your vehicles for sale, please confirm whether you wish BAAA to rep those vehicles, or whether you will be doing so. We will review the procedures for that process when you register. We will then remind you of the steps we each need to take, when you arrive. One of the requirements will be that when you have completed the representation of your vehicles, we will invite you to leave the block and the lanes. Please remember that these steps are focused on both safety, and so that we can maintain the number of individuals in the auction lanes, and the building, within approved levels.
