

## GSA PUBLIC SIMULCAST BUYERS AT BEL AIR AUTO AUCTION

### **Eligibility of Bidders**

\*All bidders must be at least 18 years of age. Registration form must be completed and returned prior to 8:30am on the day of sale.

\*A copy of a valid driver's license or other accepted form of federal, state or local government issued photo identification along with a valid email address and phone number will be needed in order to register.

### **Payments**

**Must be made in full the day of sale by 4pm. If you purchase a vehicle online please contact Laura Baranowski at 410-510-0602 to provide your form of payment.** Acceptable forms of payment by Bel Air Auto Auction:

\*Cash

\*Bank Wire

\*Credit Card (MasterCard, Visa, American Express, Discover)

Effective June 1, 2015, the daily limit per credit card account is \$24,999.99

No more than two credit cards may be used to render payment for any one vehicle

Cashier's Check, Money Order, Personal or company checks will only be accepted when accompanied by a bank letter guaranteeing payment. This letter must state that the bank will guarantee the check for a specific amount for a minimum of 30 days after the specific sale date at which it is intended to be used, and that it covers the purchase of U.S. Government property only. The letter must be signed by the bank official affirming the guarantee (must be made payable to Belair Auto Auction),

\*Debit cards (require a PIN and can only be processed in person).

**It is required by GSA that we provide for their records, buyer's social security number and obtain buyers signature on all sale documents. This must be obtained no later than 4pm the day of sale.**

### **Removal of purchased property**

\*Vehicles must be removed the day of sale by 4pm unless other arrangements have been made with the auction facility.

\*You must display a valid driver's license or other form of identification to obtain an auction issued gate pass which is required to remove vehicles from the auction facility.
